

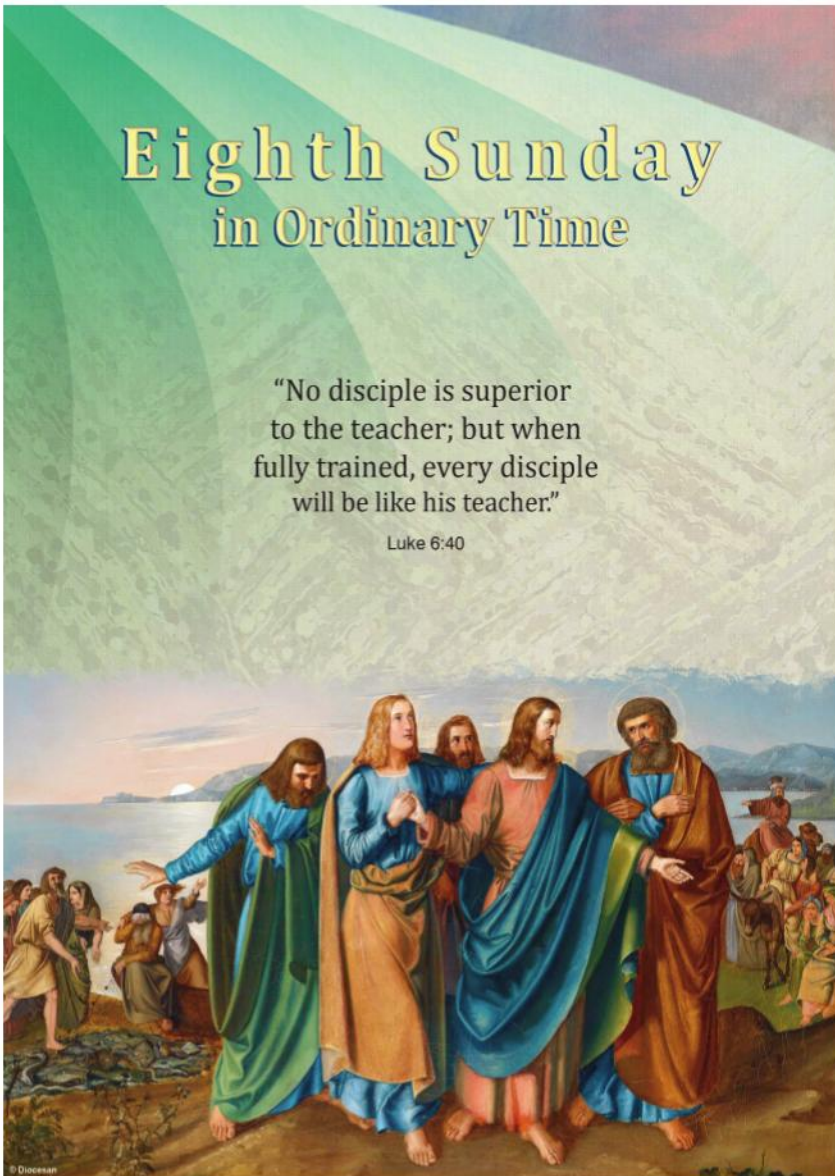

A TIME FOR REFLECTION

Every day, most of us look in the mirror and see our reflection. We may be shaving, putting on make-up or combing our hair, but we all need to see ourselves in the mirror to make sure everything is "just right." That takes care of our exterior. But what about our interior - our souls? If we could see a reflection of what's on our souls, what would we see? Would we see that everything is "just right"? Well, the Church gives us Lent every year to correct whatever may not be right with our inner beings.

Ash Wednesday is only three days away, so it's time to get in that prayer-fasting-almsgiving-reflective mindset that accompanies the Lenten season.

The Church gives us readings today that put us into that mode of thinking. Our first reading from Sirach gives us a series of reflective statements for us to ponder, primarily guarding against sins that are spoken. (This is another reading using synthetic parallelism, as I spoke of in my last homily). And Jesus provides us a series of thoughts to reflect on in our gospel selection from Luke.

Jesus uses a lot of Q & A to get his points across. For example: "*Can a blind person guide a blind person? Will not both fall into a pit?*" This is a great rhetorical technique which we can see gives us an opportunity to reflect on both parties. If we are going to lead, we need to lead people in the light of Jesus. Conversely, if we are to follow, we must follow one who leads in the light of Christ. Both teacher and student must be in the light. Those of us in leadership roles, as parents, teachers, and business and community leaders, should use

Lent to re-evaluate how we lead--making sure that we stay in the light.

After all, when we look in the mirror in the morning we can only see what we look like. Lent gives us a better opportunity to see who we are.

NOTE: We haven't run an adult faith formation series in almost two years due to Covid, but we will get back into the swing of things this week as I host viewings of the popular streaming series *The Chosen*, followed by group discussion. I will hold morning and evening sessions in the church basement beginning this Thursday March 3rd and running through April 28th. There is no cost for this program. Please sign up through the parish office.

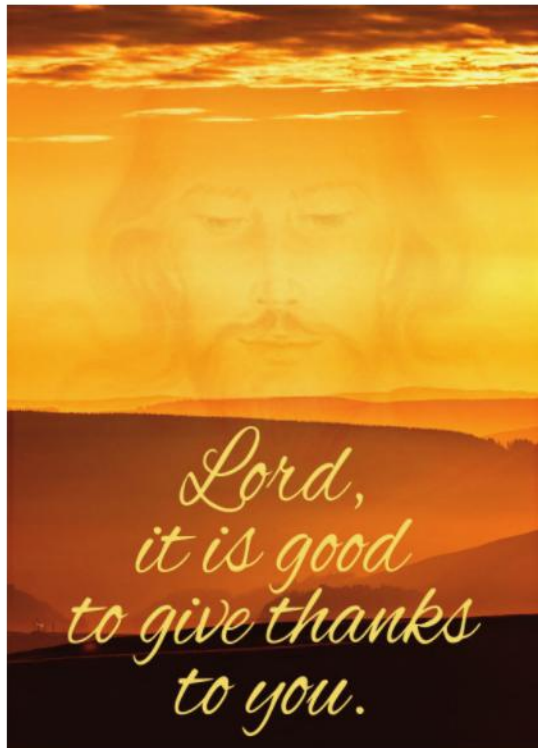

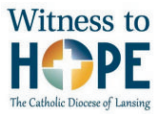
